#### I. INTRODUCTION

Severe, official punishment is appropriate for millions of collectivists in America. In fact, collectivist Americans are knowingly perpetrating treason by aiding, and comforting, incestuous homosexual illegal immigrants who are intentionally trying to destroy America's tradition of real freedom by furthering incestuous homosexual culture. Specifically, collectivist Americans understand the determinative influence of incestuous homosexual culture in illegal immigration and therefore perpetrate treason by supporting "sanctuary" laws, and amnesty. Additionally, by supporting legal rights for incestuous homosexuals while ignoring, or downplaying, the criminal nature of incestuous homosexual culture, collectivist Americans are also perpetrating rebellion against our normal heterosexual *Constitution*, and our republican form of government, both of which are controlled by America's charter of freedom, that "all men are created equal". Consequently, conservative heterosexual Americans must determine the appropriate punishment for millions of collectivists in America, including legal execution for treason in immigration matters.

### II. AMERICA'S CHARTER OF FREEDOM

1. "All men are created equal" is a very specific, universal, and practical belief, not idealism. In fact, "all men are created equal" means that since government officials are not superior to anyone else they must adequately reflect truth and reason as they exercise government power over the American people; otherwise, they deserve to be punished including in many cases with the death penalty. Indisputably, that is exactly what "all men are created equal" meant in the Revolutionary Era, and in the Civil War Era; and that is exactly what it means today.

Therefore, it's wrong to state that "all men are created equal" is merely an ideal which is not legally binding. For "all men are created equal" is the charter of America's normal heterosexual tradition of real freedom, which controls all legitimate public policy. Additionally, like all other normal heterosexual culture, "all men are created equal" runs with the *Constitution* at all times. In fact, the *Constitution* must first be amended to allow public officials to *not* practice "all men are created equal". Consequently, "all men are created equal" is also a legal argument of last resort when public officials are non-responsive to truth and reason, including Abraham Lincoln's defense, and advocacy, of the charter in the 1850s and 1860s.

2. No one is above the law, especially America's highest law that "all men are created equal". Additionally, when public officials don't obey America's charter of freedom we begin enforcing it more aggressively. In fact, conservative heterosexuals in contemporary non-institutional America have reaffirmed their preeminent function

which is leading the enforcement of America's highest law. For example, since 2008 we've enforced it to the extent that homosexuality, and everything else to the left of conservative, are now on the irreversible path to ultimate extinction. In particular, the enforcement of "all men are created equal" by conservative heterosexuals in non-institutional private society is now permanently destroying collectivist enemies of America's tradition of real freedom in our current systemic money problem, the Great Recession. Obviously, that is a tremendous improvement from conservative heterosexuals' temporary, and partial, defeats of collectivist enemies in America's first three systemic money problems, "taxation without representation", slavery, and the Great Depression.

Thus, America's charter of freedom, the spirit of truth, is in fact the law, and the highest of all of America's laws; it is also a natural law that normal heterosexuals always obey, and the mandatory ideological source for all other laws. Not surprisingly, failing to aggressively enforce America's highest law destroys America's normal heterosexual tradition of real freedom including the *Constitution*, our republican form of government, and capitalism.

- 3. "All men are created equal" doesn't mean that every person is born with the same physical, and mental, capabilities as every other person, or that every person is entitled to as much success as every other person. Nor does it mean that every person is born into a family that is as good as every other family or as wealthy as every other family. Furthermore, "all men are created equal" doesn't mean that every person will develop the same talents as every other person, or experience the same life as every other person, or live as long as every other person. It also doesn't mean that every person is born as free as every other person or in a nation as good as every other nation, or that every person is entitled to "dignity and respect" under the law. For, in reality, "all men are created equal" means that since government officials are not superior to anyone else they must base their exercise of government power on truth and reason instead of any lesser self-interest, personal problem, or personal culture which is not normal heterosexual culture. Additionally, the Founders stated in the Declaration of *Independence* that government officials who do not obey "all men are created equal" are interfering with mankind's God-given right to life, liberty, and the pursuit of happiness and consequently deserve death.
- 4. The Founders never defined "all men are created equal". However, there was no need to define it because everyone knew that the King, and other public officials, were not basing their exercise of government power on truth and reason, and were ignoring legitimate public policy.

Additionally, Abraham Lincoln correctly stated that "all men are created equal" is the charter, or the official grant of privileges, for America's normal heterosexual

tradition of real freedom. Yet, Lincoln never *fully* defined "all men are created equal", even during the *Lincoln-Douglas Debates*, and even though he knew exactly what it meant. Furthermore, Lincoln never fully defined it even while Douglas, and many other of Lincoln's contemporaries, continued to wrongly believe or propagate that "all men are created equal" did not include blacks because blacks were slaves when it was adopted. Obviously, that belief is wrong because "all men are created equal" means that government officials are not superior to anyone else and therefore the exercise of government power must be based on truth and reason, which precluded both the perpetual continuation of slavery and the perpetual prohibition on women's right to vote.

In reality, Lincoln extensively argued "all men are created equal" without fully defining it partly to learn what Douglas, and many other of Lincoln's adversaries, understood the charter to mean. Thus, by not fully defining the charter Lincoln kept some of the most important information from his adversaries, while at the same time humanely giving his adversaries enough information to know both his genuine beliefs and his genuine intentions. Also, I'm certain that Lincoln would not fully define the charter if he believed his political adversaries were not genuinely attempting to further America's normal heterosexual tradition of real freedom including the Constitution, our republican form of government, and capitalism, or were not giving the tradition enough "dignity and respect". Even more obvious, Lincoln did not fully define the charter partly because he mistrusted, and did not entirely understand, the ultimate motivation behind his adversaries' political objectives and therefore did not want to reward his adversaries. Interestingly, in hindsight it appears that Lincoln observed either oppositesex incestuous sexual activity or other behavior that made him suspect opposite-sex incestuous sexual activity among his adversaries. Yet, Lincoln saw darkly as through a mist, for he did not understand the incestuous sexual activity, or other behavior, was merely a component of homosexual culture.

Nevertheless, Lincoln provided enough of his accurate understanding of America's charter of freedom, and of how the charter differed from what many of his adversaries believed it to mean or pretended to believe it to mean. For example, he relied upon the charter to refute incestuous homosexual Democrats' arguments that democracy or popular sovereignty was the constitutionally permissible justification for public policy including the perpetual continuation of slavery. In fact, Lincoln correctly responded that America's charter of freedom, the spirit of truth, *is* all of the democracy that exists in America. More specifically, "all men are created equal" is all of the democracy *that ever will exist* in America until an amendment to the normal heterosexual *Constitution* provides otherwise.

# III. <u>ENFORCING AMERICA'S CHARTER OF FREEDOM WITH SEVERE,</u> <u>OFFICIAL PUNISHMENT</u>

1. The death penalty is an appropriate punishment for millions of collectivist Americans. In fact, both homosexual and collectivist heterosexual Americans' support for incestuous homosexual illegal immigrants, including amnesty, and "sanctuary" policies, and incestuous homosexual Americans' failure to reveal for more than half a century that incestuous homosexuals constitute at least a large majority or disproportionately large percentage of illegal immigrants, are obvious examples of treason which is a capital offense. Furthermore, all incestuous homosexual Americans who knowingly participated in the transportation or safekeeping of incestuous homosexual illegal immigrants perpetrated treason.

Incidentally, by supporting "sanctuary" policies, and amnesty, both homosexual and collectivist heterosexual Americans are defying "all men are created equal" or intentionally pitting government, and other institutions, against established truth and reason. For example, that incestuous homosexuality has a treasonous, and determinative, connection to illegal immigration. Thus, supporting "sanctuary" policies, and amnesty, is also rebellion against the *Constitution*, and our republican form of government, both of which are controlled by America's charter of freedom, that "all men are created equal".

2. Advocating for the death penalty for incestuous homosexuals who perpetrate treason in immigration matters is consistent with the legal, deserving, and good-intentioned exercise of the death penalty in modern America. For example, all or almost all people convicted of a capital offense and consequently legally executed were incestuous homosexuals. Furthermore, all or almost all people killed by American citizens exercising their right to defend themselves were incestuous homosexuals. Also, all or almost all Americans justifiably killed by law enforcement personnel were incestuous homosexuals. Lastly, a large majority of the radical Islamic terrorists justifiably killed by America's armed forces were incestuous homosexuals including tens of thousands of members of the Islamic State. Thus, a large part of America's purpose, and identity, in the 21st Century, as it was in centuries past, is legally executing the worst incestuous homosexuals.

Consequently, advocating for the death penalty for incestuous homosexuals who perpetrate treason in immigration matters is merely urging public officials to logically take America's current exercise of the death penalty to the next appropriate level by legally executing the incestuous homosexual allies, and co-conspirators, of other kinds of incestuous homosexuals who are routinely, and legally, executed.

3. The Democratic Party, especially its incestuous homosexual leaders, is responsible for the large number of illegal immigrants in America, for unconstitutional public policy favoring illegal immigrants, including "sanctuary" laws, and for making

America more dangerous for all Americans. Not surprisingly, incestuous homosexual public officials refuse to handle incestuous homosexuals aggressively enough, including incestuous homosexual foreigners traveling to America. The dominant reasons are first, that the incestuous homosexual public officials will be severely criticized by many other incestuous homosexuals, and second, that incestuous homosexuals will have a substantially more difficult time furthering incestuous homosexual culture in America. Therefore, incestuous homosexual public officials are permissive with incestuous homosexual illegal immigrants, and with other incestuous homosexuals all of whom aim to illegally destroy America's tradition of real freedom including our normal heterosexual *Constitution*, our republican form of government, and capitalism.

Practically speaking, incestuous homosexual public officials won't give their best effort to stopping criminal activity, which is exactly what is required to both fulfill their constitutional obligation and to stop incestuous homosexuals from at least substantially damaging America. Additionally, with "sanctuary" laws incestuous homosexual public officials provide aid, and comfort, to illegal immigrants whom they know are incestuous homosexuals that are intentionally defying, and trying to destroy, America's tradition of real freedom by furthering incestuous homosexual culture. Also, "sanctuary" laws ignore the determinative, and illegal, incestuous homosexual influences in illegal immigration and therefore defy the spirit of truth, that "all men are created equal". Thus, "sanctuary" laws are an additional front in America's civil, civil war between collectivists and conservatives, or an additional component of collectivists' rebellion against our normal heterosexual *Constitution*, and our republican form of government. More importantly, "sanctuary" laws are obvious examples of treason which makes Americans who support the policies eligible for the death penalty.

4. All men are created equal. Therefore, considering the overwhelming amount of empirical evidence verifying the subjective, fraudulent, irrational, criminal, and deadly nature of incestuous homosexuality, any public official who knowingly supports or furthers incestuous homosexual culture in public policy should be severely punished. For example, collectivist heterosexual Democrat public school officials perpetrate rebellion against America's normal heterosexual *Constitution*, and our republican form of government, by supporting "dignity and respect" for transcestite students, contrary to established truth concerning the criminally abusive familial origins of transcestism. Also, collectivist heterosexual Democrat law enforcement officials perpetrate treason which is a capital offense by supporting "sanctuary" laws that give "dignity and respect" to illegal immigrants ahead of the safety of American citizens, and contrary to established truth concerning the determinative incestuous homosexual connection to illegal immigration.

Until recently, at least either a large minority or a majority of incestuous 5. homosexual Americans knew, without the rest of the American people knowing, that at least a disproportionately high percentage or a majority of illegal immigrants are incestuous homosexuals. Furthermore, the motive for the secrecy of these incestuous homosexual Americans has always been allegiance to incestuous homosexual culture which requires them to support the illegal immigration of incestuous homosexuals, amnesty for incestuous homosexual illegal immigrants, and other immigration policy that illegally, irrationally benefits incestuous homosexuals in particular. Without a doubt, at least almost all incestuous homosexual illegal immigrants would never have crossed the border into the U.S. if they didn't believe that incestuous homosexual public officials, incestuous homosexual relatives, and other incestuous homosexuals would substantially aid or comfort them. More importantly, these incestuous homosexual Americans are perpetrating treason because they know that the incestuous homosexual illegal immigrants they're aiding or comforting are attempting to destroy America's normal heterosexual tradition of real freedom by furthering incestuous homosexual culture. They're also perpetrating rebellion because they know the incestuous homosexual illegal immigrants practice a subjective, fraudulent, criminal culture which defies America's normal heterosexual *Constitution*, and our republican form of government.

Incidentally, without the exposure of incestuous homosexual culture, which began in non-institutional private society, the incestuous homosexual illegal immigrants, incestuous homosexual institutional officials, and other incestuous homosexual Americans would have made the next logical step forward in America's normal heterosexual tradition of real freedom take substantially more time to complete, and substantially more difficult including deadlier, bloodier, and more violent.

6. All public officials who defy "all men are created equal" deserve severe, official punishment. For example, to comply with homosexual culture, incestuous homosexual Democrat public officials consistently vote against large tax cuts, and other capitalistic public policy that would end the Great Recession as quickly as possible, including the substantial monetary hardship experienced by tens of millions of American adults. Also, incestuous homosexual "Republican" public officials balance their pro-capitalistic votes with support for anti-capitalistic laws that further incestuous homosexual culture including amnesty, "sanctuary" cities, abortion, and homosexual rights. Thus, incestuous homosexual public officials' anti-capitalistic, or duplicitous, voting behaviors form an additional front in incestuous homosexuals' rebellion against our normal heterosexual *Constitution*, and our republican form of government, both of which are controlled by America's charter of freedom, that "all men are created equal".

Additionally, all collectivist heterosexual Democrat public officials who support illegal immigration via "sanctuary" laws, or amnesty, are knowingly perpetrating treason, and deserve to be severely punished including with the death penalty.

Practically speaking, these collectivist public officials are aiding, and comforting, incestuous homosexuals who are illegally trying to destroy our normal heterosexual *Constitution*, our republican form of government, and capitalism by furthering incestuous homosexual culture. Likewise, all collectivist heterosexual Democrat public officials who support legal rights for transcestites despite the extremely subjective, criminal, and fraudulent nature of incestuous homosexual culture deserve severe punishment. Specifically, these heterosexual public officials know that incestuous homosexuals' criminally abusive family practices are the fundamental reason *why* transcestites do not support our normal heterosexual *Constitution*, and our republican form of government, both of which are controlled by America's charter of freedom, that "all men are created equal". Consequently, these heterosexual public officials are aiding, and comforting, incestuous homosexual Americans perpetrating rebellion.

- 7. Considering all of the harm that anti-capitalist policies have caused in America, homosexual, and collectivist heterosexual, public officials who vote against big tax cuts, tax reform, and other capitalism to comply with collectivist culture deserve severe, official punishment. In fact, these collectivist public officials are knowingly, and illegally, trying to destroy America's normal heterosexual tradition of real freedom by virtually impoverishing or destroying the livelihoods of enough Americans to consequently make it inevitable that taxes will be raised, and that government power will determinatively increase in other ways. Thus, by voting against capitalism, collectivist public officials are intentionally defying established truth and reason concerning the solution for the substantial monetary suffering of tens of millions of American adults, which makes their defiance rebellion against our normal heterosexual *Constitution*, and our republican form of government.
- 8. Both tens of millions of collectivist heterosexuals and at least a very large majority of homosexuals who vote continue to support the Democratic Party despite the harm caused by anti-capitalistic policies. More importantly, they continue to support the Democratic Party because they're united in rebelliously attempting to destroy America's normal heterosexual tradition of real freedom including capitalism, *not* because they believe the Democratic Party's policies are truthful and rational, or that the policies are successful, or because they substantially respect each other. Furthermore, they're united because each group opposes "all men are created equal" or the spirit of truth as the exclusive basis for legitimate public policy. Thus, each group aspires to the same goal of making its culture which is not normal heterosexual culture preeminent or, at least, to make truth and reason share the spotlight with its personal culture or personal problems. Stated differently, each group prefers a nation of men governed by its personal problems or its personal culture which is not normal heterosexual culture, not a nation of laws built upon America's charter of freedom, that

"all men are created equal". Consequently, by voting Democrat both homosexuals and collectivist heterosexuals are perpetrating rebellion against our normal heterosexual *Constitution*, and our republican form of government.

#### IV. <u>CONCLUSION</u>

America continues to rise in an increasingly conservative direction, and everything to the left of conservative is on the irreversible path to ultimate extinction. But does that ruin conservative heterosexuals' ability to inflict severe, official punishment on millions of collectivist Americans, including legal execution for treason in immigration matters?

Until recently, many Americans wouldn't have believed severe, official punishment for a large number of collectivists is a realistic goal partly because the outward support for the punishment among a substantial number of conservative heterosexuals apparently didn't exist. But the reason that support didn't exist for decades is that homosexual culture had not yet been exposed. Furthermore, the reason that support didn't exist until very recently is that we obeyed America's tradition of real freedom by exposing homosexual culture, dominated public sentiment on all important issues, and began what is now leading to both the wealthiest America and the wealthiest Earth of all time. In fact, we're now close to the end of the Great Recession, which at least substantially contributes to delaying, lessening, or entirely avoiding severe, official punishment for a large number of collectivists because the Great Recession is the only major problem that a majority of conservative heterosexuals have. Nonetheless, the possibility of inflicting the punishment remains, and the outward support for the punishment among a substantial number of conservative heterosexuals now exists, primarily because incestuous homosexual Democrat public officials did not move quickly enough, or with all deliberate speed, to end the Great Recession by cutting taxes, and adopting other capitalistic public policy.

More importantly, we must remember that unlike with other systemic money problems *any* kind of official punishment for the Great Recession, and its causes, either is or would be *secondary* punishment including election losses, imprisonment, and the death penalty. For, in reality, the preeminent, and worst, punishment occurred when non-institutional America put everything to the left of conservative on the irreversible path to ultimate extinction primarily by destroying homosexuals' ability to recruit heterosexuals whose parents are not homosexuals. Furthermore, the preeminent weapon for this punishment was non-institutional speech, the sun around which all of America's institutions must orbit, and the dominant component of America's normal heterosexual tradition of real freedom. Therefore, it's possible that contemporary conservative heterosexuals ultimately choose not to inflict severe, official punishment on a large number of collectivists because of what's already been achieved in non-

institutional America and consequently in public policy by aggressively enforcing America's charter of freedom, that "all men are created equal".

#### **APPENDIX**

#### A1. CONSTITUTIONAL INTERPRETATION

- 1. The *Declaration of Independence* controls all legitimate interpretations of the *Constitution*. Therefore, the *Constitution* must be interpreted according to normal heterosexual culture. For "all men are created equal" is normal heterosexual culture, and originated in conservative heterosexuals who allowed normal heterosexual culture to dominate their decision-making.
- 2. The Founders didn't require the *Declaration of Independence* to be proven false for Americans to break from America's normal heterosexual tradition of real freedom. In fact, the Founders required only that the *Constitution* be amended to achieve that goal.

Nonetheless, the fact that the Founders made amending the *Constitution* moderately difficult by requiring a large majority of either "both Houses" or states to propose an amendment, and an even larger majority of either state conventions or legislatures to ratify the amendment, is another example of the Founders' preference for a republic instead of a democracy. Specifically, when the *Constitution* was adopted the spirit of truth remained the highest law of the land because the *Declaration of Independence* controlled the *Constitution*. Thus, to reinforce the preeminence of "all men are created equal" as the charter of America's tradition of real freedom, the Founders made breaking from the tradition via constitutional amendment moderately difficult.

Additionally, the Founders didn't require unanimous approval from the states to amend the *Constitution*. The reason is that unanimous consent would allow messed-up heterosexuals, and homosexuals, to negatively influence public policy under the *Constitution* like they negatively influenced public policy under the *Articles of Confederation* which required unanimous consent. Therefore, less than unanimous consent to amend the *Constitution* also reinforced the Founders' preference for a republic instead of a democracy. Specifically, less than unanimous consent made it substantially easier for the large majority of normal heterosexuals to maintain the preeminence of the spirit of truth in public policy by not having to rely upon messed-up heterosexuals, and homosexuals, for support.

3. The truth and reason expressed by Abraham Lincoln, and other conservatives, in the 1850s - 1860s formed the ideological, and traditional, basis for the 13<sup>th</sup>, 14<sup>th</sup>, and 15<sup>th</sup> Amendments to the Constitution. Furthermore, none of the three Amendments has been repealed, or ideologically changed, and, more importantly, contemporary normal

heterosexual culture does not conflict with any of the three *Amendments*. Neither has the *Constitution* been amended by abolishing or superseding the truth and reason expressed by Lincoln, and his contemporaries, which led to them interpreting the *Constitution* as they did, fighting the Civil War, ending slavery, and adopting the three *Amendments*. Even better, it is indisputable that "all men are created equal" is the heart, mind, soul, and spirit of Lincoln's truth and reason, and what he accurately called the charter of America's freedom that connects, *and equalizes*, Colonial- and Revolutionary-era, Americans with all succeeding Americans, both native- and foreign-born individuals alike. Furthermore, the charter is normal heterosexual culture, and originated in conservative heterosexuals who allowed normal heterosexual culture to dominate their decision-making.

Incidentally, Lincoln also called the *Constitution* America's charter of freedom. Nonetheless, it's more important that he called "all men are created equal" the charter because he believed the *Declaration of Independence* controls all legitimate interpretations of the *Constitution*. Thus, Lincoln calling the *Constitution* the charter is evidence of his correct belief that without a constitutional amendment "all men are created equal" is inseparable from the *Constitution*.

4. The 14<sup>th</sup> Amendment has not been ideologically changed since it was originally adopted in response to circumstances that are very similar to America's current civil, civil war including the Great Recession, and that were decided in favor of normal heterosexuals, and the spirit of truth, that "all men are created equal".

Sadly, contemporary homosexual, and collectivist heterosexual, public officials are interpreting the 14<sup>th</sup> Amendment including the Equal Protection Clause contrary to normal heterosexual culture by favoring homosexuals whose subjective, fraudulent, and criminal culture defies "all men are created equal". In reality, these public officials are now interpreting the 14<sup>th</sup> Amendment according to the same incestuous homosexual, and collectivist heterosexual, cultures which defied the spirit of truth and consequently led to the Civil War, and which the 14<sup>th</sup> Amendment was designed to defeat.

Therefore, homosexual, and collectivist heterosexual, public officials' interpretations of the 14<sup>th</sup> Amendment and subsequent public policies are obviously wrong, and unconstitutional. Furthermore, these policies form a major front in homosexuals', and collectivist heterosexuals', rebellion against the normal heterosexual Constitution, and our republican form of government, both of which are controlled by the spirit of truth, that "all men are created equal".

## A2. AMERICA'S TRADITION OF REAL FREEDOM: PAST, PRESENT, AND FUTURE

- 1. America is an *extremely* traditional nation. In fact, homosexuals, collectivist heterosexuals, and conservative heterosexuals in contemporary America are following the same traditions that homosexuals, collectivist heterosexuals, and conservative heterosexuals have followed for the entirety of America's four hundred plus year tradition of real freedom. More importantly, both homosexuals and collectivist heterosexuals are so extremely traditional that they continue to follow *losing* traditions. But conservative heterosexuals are still following a winning tradition of real freedom, and are now taking the biggest, most beneficial step forward of all in that tradition.
- 2. Contemporary conservative heterosexuals are now taking the biggest, most beneficial step forward in America's four hundred plus year tradition of real freedom including the steps taken by conservative heterosexuals in the Colonial, Revolutionary, and Civil War generations.

For example, the Founders adopted the *Constitution* the purpose of which is to maintain the preeminence of the spirit of truth, that "all men are created equal", in public policy. However, contemporary homosexuals, and collectivist heterosexuals, are not obeying the *Constitution* in important ways. But *official* punishment has been far less than proportionate to the severity of the disobedience. In reality, non-institutional America, *not government*, has come to the rescue including by putting homosexuality, and everything else to the left of conservative, on the irreversible path to ultimate extinction. Additionally, not even the Civil War punished homosexuals, and collectivist heterosexuals who disobeyed our normal heterosexual *Constitution* as effectively, and productively, as we're punishing their like-minded successors in contemporary America.

Therefore, just because contemporary conservative heterosexuals are obeying the *Constitution* doesn't mean that the document is a bigger, or equal, step forward in America's tradition of real freedom compared to the step forward we're taking now. In fact, the opposite is true: the *Constitution* including the *Bill of Rights* is a substantially *smaller* step forward than the step we're taking now.

3. The Republican Party was formed to combat illegal popular sovereignty or majority-rule democracy, and to reaffirm that "all men are created equal", the spirit of truth, is the charter of America's normal heterosexual tradition of real freedom including the *Constitution*, and our republican form of government. Additionally, the Republican Party was formed prior to the exposure of homosexual culture. However, I believe that in the 1850s Abraham Lincoln suspected the influence of incest in the Democratic Party's platform, and in the conspiratorial behaviors of pro-slavery public officials, and openly expressed his suspicion through Shakespeare's writings, and with other words. Also, I believe the southern states' decision to secede from the Union was the result of not wanting to give Lincoln dignity and respect. The dominant reason is

that during the 1850s, in his defense of "all men are created equal" as the charter of America's tradition of real freedom, Lincoln spoke "too personally" by publicly referring to the incestuous lifestyles of many pro-slavery Americans, without necessarily knowing, and without indicating, those Americans were also homosexuals. Thus, Lincoln saw darkly as through a mist when he spoke without understanding the influence of homosexual culture in the events of his day.

Nonetheless, in our current defense of "all men are created equal" as the charter of America's normal heterosexual tradition of real freedom we've adopted, and tremendously furthered, Abraham Lincoln's strategy in the 1850s and 1860s by revealing homosexual culture including incest as the dominant threat to both America and the rest of the world. More importantly, we began America's evolution beyond the battle between conservatives and collectivists, which has been the dominant influence on the tradition from the very beginning. Furthermore, this evolution made the Great Recession the last systemic money problem that America will ever have, and ensured a permanently conservative heterosexual future for America. In fact, we're now on the way to an America in which, for the first time ever, collectivism does not have at least a significant influence. Therefore, practically speaking, in 2008 we concluded the first generation of America's normal heterosexual tradition of real freedom, which lasted over four hundred years, and began the second, which is the greatest deed ever achieved in the entirety of the tradition.
